Brief Note on CCITP

The Chamber of Commerce for Iran Trade Promotion (CCITP), a bilateral chamber is established as a society in the month of September'2012 at Hyderabad, with the main objective of promoting business and trade relationship between India & Iran.

India-Iran economic and commercial ties have traditionally been buoyed by Indian Import of Iranian crude oil. Iran is India's core energy partner – its second largest oil supplier. Nearly 12 percent of India's total demand, around 4,00,000 barrels a day, feeds India's refineries and petrochemical complexes.

India's exports to Iran have increased from US S 1.4 billion in 2006-07 to US \$ 2.7 billion in 2010-11.

Main focus areas include:

Granites, Bulk Drugs and Pharmaceuticals, IT and ITES, Engineering Goods, Tea, petroleum products, rice, machinery & instruments, manufactures of metals, primary and semi finished iron & steel, fine chemicals, processed minerals, manmade yarn & fabrics, organic / inorganic / agro chemicals, rubber manufactured products, Food Commodities like Sugar, Corn, Soybean, Dried fruits, Saffron, Dates, Fruits, Meat, Cooking oil, oil cak,, Food additive, Raw material and additives for animal feeding, Banking, Establishing Mutual Banking Relations, Petrochemical, Oil and Gas, Textiles, Water treatment System, Raw Materials for Chemical, Pharmaceutical and other industries, Ethoxilated Alcohols (PEG/MPG/MEG) Phenol, Bituman, Urea, Potassium chloride, Potassium sulphide, Parenterals, Sterile vials for injections, Petrochemical Silicon, Calcium Carbonate, Iron Ore, Lead Ingot, Zinc Ingot, Aluminum billet, Sheep pickled skin, Crust leather etc

India and Iran are in discussions for the setting up of a number of projects such as the IPI gas pipeline project, a long term annual supply of 5 million tons of LNG, development of the Farsi oil and gas blocks, south Pars gas field and LNG project, chahbahar container terminal project and Chahbahar-Faraj – Bam railway project, etc. India and Iran hold regular bilateral talks on economic and trade issues at the Indo-Iran Joint Commission Meetings (JCM). Both India and Iran hold Joint Business Council meetings regularly.

High level Business delegations from Hyderabad are visiting Iran regularly since 2011. CCITP has signed MOUs with Tehran, Bushehr & Shiraz Chambers of Commerce & Industries for promoting Business & Trade with Iran. High level business delegations also visiting Hyderabad from Iran from time to time.

- Providing arbitration in respect of disputes arising in the course of trade, industry or transport or other business matters, and to secure the services or experts, technical and other men, if necessary or desirable etc.
