

Current Status of Indian Biopharma Industry

Indian Biopharma industry is advancing into new heights in tandem with the growth and progression observed globally. India is counted among the top 12 global biotech hotspots and is the 3rd largest in Asia Pacific (in terms of number of biotech companies). Bio Pharma remained the largest contributor to the sector. Diagnostics, vaccines and recombinant therapeutic proteins are the three main segments in bio pharma industry.

During FY 2005-FY 2009, the industry witnessed an impressive CAGR of around 26.5% and generated total revenue of INR 121.4 Billion (US\$ 2.4 Billion) in FY 2009.

Currently, the biopharma segment constitutes a major part of the total biotech market. It has experienced consistent rise in revenue and the trend is likely to continue in future as well. The future outlook of the overall biotech market remains buoyant despite the recent economic downturn. The baseline for optimistic future projection of the market is pouring of investments to promote research and support entrepreneurship in the emerging segments.
