Indian Pharma Export Performance:

Pharmaceutical exports of India during 2010-11 are to the tune of Rs. 47,363 (US\$ 10.4 billions) Major products exported include APIs, Pharmaceutical Formulations, biotech products, veterinary drugs, Medical devices/ Surgicals, AYUSH products, etc. India exports to about 230 countries / colonies with more than 50% of exports to the Regulated Markets. Pharma Sector contributed about 5% of the country's total merchandise exports during 2009-10. Indian pharmaceutical industry is establishing itself in the global markets by adopting the international quality standards, which is evident from the facts that it ranks first in type II DMFs with US FDA, having about 1000 WHO cGPM approved pharmaceutical plants, 153 EDQM plants, highest number of Certificate of Suitability (about 805) granted by EDQM at the end of July 2011. Indian Pharma Industry is cementing itself as Global Pharmacy for quality Generic Medicines at affordable prices.

Latin American Countries:

LAC Region is very important pharma exporting destination for India.
