National SC ST Hub Scheme



Special Credit Linked Capital Subsidy Scheme (SCLCSS)

25% Capital Subsidy for SC-ST Micro and Small Enterprises on procurement of Plant & Machinery through bank loan (maximum subsidy- Rs. 25 Lacs). for SC/ST MSEs in both manufacturing and service sector



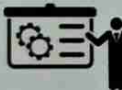
Training fees of top 50 NIRF Management Institutes

Reimbursement of 90% up to Rs. 1,00,000/- for attending up to 2 training courses from top 50 NIRF ranked Management Institutions as identified by Ministry of Human Resource Development.



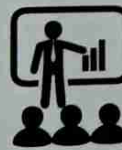
Special Marketing Assistance Scheme (SMAS)

Subsidy for participation in 4 Domestic and 2 Foreign exhibitions including virtual in a financial year



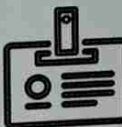
Assistance for registration under Single Point Registration Scheme (SPRS)

100% subsidy for SC/ST MSEs on registration fee of "Single Point Registration Scheme" and only a token amount of Rs. 100/- plus GST to be paid.



Capacity Building Training Programs

SC/ST aspiring and existing Entrepreneurs may attend anyone of the approved skill training programs (residential or non-residential) free of charge. Toolkits are provided after successful completion of Training.



Membership fee of various Export Promotion Councils

Reimbursement of 80% with a limit of Rs. 20,000 on annual membership fees charged by EPCs



Bank Loan processing charges

Reimbursement of 80% or Rs. 1,00,000/-, whichever is less, on bank loan processing charges paid by SC/ST MSEs for availing business loans.



Bank charges for Performance Bank Guarantee for participation in Government tenders

Reimbursement of 80% or Rs. 1,00,000/-, whichever is less, on Performance Bank Guarantee charges paid by SC/ST MSEs for participation in tenders of Central/State Govt. and CPSEs.



Reimbursement of membership fee of Government promoted E-Commerce Portals

Reimbursement of Annual Membership / Subscription fee of 80% or maximum of Rs. 25,000/-, whichever is less of Government promoted e-commerce portals such as GeM, e-khadi, TRIFED, Tribes India, B2B Portal -MSME Mart (NSIC), etc. to SC/ST MSEs.



Testing charges

Reimbursement of 80% on testing fee charges by various NABL or BIS accredited laboratories for raw material, finished product & other type of testing with a ceiling limit of Rs. 1,00,000/- per SC/ST MSE, whichever is lower, in a given Financial year.



Special Vendor Development Program

Platform to SC-ST Entrepreneurs to provide details in terms of vendor registration procedures, documentation & items being procured by Government Departments/CPSEs.
